Bylaw 72 - 2020

Being a bylaw to appoint members to the various boards, committees and authorities in the Municipality of West Grey

Whereas the Municipal Act, 2001, as amended, Section 5(3) provides that a municipal power, including a municipality's capacity, rights, powers and privileges under Section 9, shall be exercised by bylaw unless the municipality is specifically authorized to do otherwise; and

Whereas the Municipal Act, 2001, as amended, Section 8 confers broad authority on municipalities thereby allowing them to govern their affairs as they consider appropriate and to enhance their ability to respond to municipal issues; and

Whereas the Municipal Act, 2001, as amended, Section 11 provides that a municipality may provide any service or thing that the municipality considers necessary or desirable for the public; and

Whereas the Council of the Municipality of West Grey deems it expedient to appoint persons to provide for and assist in the administration, protection and management of the municipality; and

Whereas Council may, by resolution, appoint members to Ad Hoc committees for the purpose of managing projects of a specialized nature; and

That the appointments set out herein shall coincide with the term of Council unless otherwise specified; and

That the appointments of citizens and members of Council shall remain in effect until replacement appointments are made by resolution or amendments to the Appointment Bylaw;

Now therefore be it resolved that the council of the Corporation of the Municipality of West Grey hereby enacts as follows;
