

## Redevelopment

The payment of development charges is exempt with the proof of demolition being taken place within five years of redevelopment on the property.

## Additional Dwelling Units

Additional dwelling units in a basement or as an addition or as a detached structure, may qualify for a development charge exemption under the Development Charges Act.

## Development Charge Collection

Development charges are required when a building permit is issued.

If the development charge remains unpaid after it is payable, the remaining amount will be added to the tax roll and will be collected in the same manner as taxes.

This information contained herein is intended only as a guide. Interested parties should review the approved bylaws and consult the Municipality of West Grey staff to determine the applicable charges that may apply to their specific development proposals.

## Purpose of Development Charges

Development charges help to finance capital projects required to meet the increased need for services resulting from growth and development. Development charges are fees and may only be allocated for the purposes outlined in the bylaw.

## Terms of Bylaw

Bylaw No. 31-2020 will remain in force until April 28, 2025 unless it is repealed at an earlier date.

## Services Covered

Development charges have been imposed for the following services in the Municipality of West Grey, due to the increased capital costs required as a result of increased needs for services arising from development;

- Services related to a highway
- Fire protection services
- Police services
- Parks & recreation services
- Library services
- Administrative studies
