









Just wanted to advise that Dr. Robert Martin at SON visited the site this past Friday and discussed with Walker staff, and advised that the fields are not in suitable condition for SON to accept the archaeological assessment being completed now. Evidently the fields were planted and then rolled after planting, so SON won't accept the work being completed.

It was agreed that the fieldwork for your study would have to be held until +/- July 2024 once the current crop of barley that was planted comes off, and the fieldwork would be completed with SON monitors present.

I would assume your Stage 1 work could still proceed though honestly not sure of the rush need for it at the moment – let me know your thoughts on that. Otherwise your study will have to be picked up next summer.


