Record of Indigenous Engagement

Parslow Heritage Consultancy (PHC) conducted a Stage 1 and 2 archaeological assessment on Part of Lots 19 and 20, Concession 1 West of Owen Sound Road, Part of Lot 46, Concession 2 West of Owen Sound Road, Geographic Township of Normanby, now Municipality of West Grey, Grey County, Ontario (the study area). The Stage 1 and 2 archaeological assessment of the study area was conducted under PIF P1056-0223-2023.

The study area is located within the traditional territory of Saugeen Ojibway Nation (SON), the collective name for the Saugeen Ojibway First Nation and the Chippewas of Nawash Unceded First Nation.

On behalf of Teeswater Concrete, PHC engaged with SON for the duration of the Stage 1 and 2 archaeological assessment. Dr. Robert Martin of SON's environmental office participated in the Stage 2 fieldwork between September 6 and 19, 2023. The draft Stage 1 and 2 archaeological assessment report was also provided to SON for review; SON confirmed review of the report with no concerns. An email from SON confirming their report review is attached on the next page.

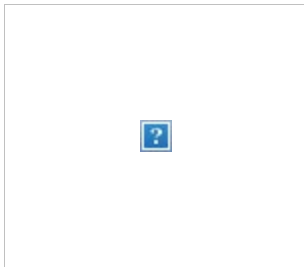
